## Drawing/Contest OFFICIAL RULES

### Drawing Prize - 3 \$25 Amazon eGift Cards

- 1. NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE.** Void where prohibited.

- 3. TO ENTER.** To enter you must: comment with the name and organization of a Harford County, Baltimore County, Carroll County or Baltimore City Nurse in the comments of Freedom's social media post (Facebook or Instagram), be a follower of Freedom's social media page where your nomination is submitted, and share the post. Complete these steps by 11:59 pm Tuesday, May 12, 2026.
- 4. ELIGIBILITY TO ENTER:**

Individuals must :

  - Submit the name and organization of a Harford County, Baltimore County, Carroll County or Baltimore City Nurse in the comments of Freedom's social media post. Pictures and comments about your nominee are welcome, but will not affect their chances of winning. Follow the social media page where the nomination is shared, and share the post. If all of these requirements are not met, the entrant may be forfeiting their eligibility at the discretion of the Sponsor. Drawing will be completed on or about Wednesday, May 13, 2026 at 10:00 am.
- 5. PRIZE DETAIL.**

Freedom Federal Credit Union will provide 3 Amazon eGift cards (valued at \$25 each) from the eligible entries. The prize will be emailed to the winner. Nominator may be asked to assist in providing an email address for the winning nurse. The **WINNER** may be subject to IRS 1099 form reporting if cumulative prizes are above \$500 for the year. **See #7 – 12** below, which also apply.
- 7. DRAWING AND AWARDING OF PRIZES.** Three Winners will be drawn on Wednesday May 13, 2026; following which the Winners will be verified and notified. The Winners are pulled from the nurses nominated, not necessarily the posters of those names. The winners will be posted to Freedom's social media pages. If the Winners do not claim their Prize within 10 days of notification, they are disqualified and another Winner will be drawn. Each winner must submit a valid email address and their full legal name in order to receive their prize. The Winners need not be present and will be notified by social media or email. If any prize, prize notification or attempted notification is returned as undeliverable, the prize will be forfeited and awarded to an alternate Winner.
